INTRODUCTION



MACC (Amendment) Act 2018, Section 17A (1) : Offence by Commercial Organization

Commercial organization commits an offence if any person associated with that commercial organization commits a corrupt or bribery act in order to obtain or retain business or advantage for the organization.

Section 17A (4) states that if a commercial organization is charged for the corporate liability offence, there is a defence for the commercial organization to prove that the commercial organization had in place "adequate procedures" designed to prevent person(s) associates with the commercial organization from undertaking such conduct.

The Minister in the Prime Minister's Department has issued a Ministerial Guidelines on Adequate Procedures that laid out 5 principles associated with a robust compliance system.
